CONTRACT TERMS

CREDIT CARD AGREEMENT - MONTHLY CHARGES

I understand my credit card will be charged monthly for the contracted amount due the first business day of each month. I agree to pay a late payment fee of \$20.00 per month for credit/debit card that is declined for any reason. Enrollment may be terminated for repeated credit card declines. For registrations received after the first of the month, tuition will be charged at the time of registration.

KIDS CLUB/WISE GUYS/SUMMER SONIC CONTRACT GUIDELINES

- 1. I understand that my child cannot begin the program until I receive confirmation of contract approval from KIDS Club/WISE Guys/Summer Sonic (hereafter referred to as The Program).
- 2. All requests for changes/cancellation of scheduled day must be in writing. Requests need to be received at least five business days prior to the effective date of the change/cancellation. Days cancelled without a five business day notice will require full payment. Parent will receive confirmation of change/cancellation.
- 3. I understand that monthly invoices are sent via e-mail approx. three days prior to charging my card on file. My account information is available to view 24 hours per day and all financial and schedule information pertaining to my child can be found online at edina.ce.eleyo.com.
- 4. I agree to pay the following fees (if applicable):
 - a. **Change/Cancellation Fee:** \$15 per written notice to change/cancel day(s). Changes/Cancellation require 5 business days notice.
 - b. **Registration Fee:** \$25 for registrations received after March 31, 2019.
 - c. Late Pick-Up Fee: \$1 per minute after 5:00pm closing time for Summer Sonic, 6:00pm closing time for KIDS Club and WISE Guys. Enrollment may be terminated for consistent lateness.
 - d. Late Payment Fee: \$20 per month for credit card decline for any reason. Enrollment may be terminated for repeated credit card declines.

5. No reductions in fees will be made for absences.

- 6. I understand that my enrollment will be terminated and my account may be turned over to collections if The Program is unsuccessful in collecting my monthly tuition. I agree to be responsible for all collection costs not to exceed 50% of any amount due.
- 7. I agree to list two (2) people (other than parent/guardian) on this contract who are authorized to pick up my child and/or take responsibility for my child in the case of illness/emergency. I understand that I must contact the staff to give permission for anyone other than a parent/guardian to pick up my child.
- 8. I give permission for my child to be included in photos or videos of program activities that may be used in school district publicity such as newsletters, brochures, websites and videos, and any media coverage such as newspaper or television.
- 9. I give permission for my child to participate in program field trips. I understand that program staff will supervise all field trips and I will be informed in advance of the destination and means of transportation if other than Edina Public School buses.

- 10. I give my consent to an exchange of my child's information between The Program staff and other Edina Public School professional staff whenever it would be beneficial to my child.
- 11. I give permission to The Program to make whatever emergency (i.e. first aid, disaster evacuation, etc.) measures are judged necessary for the care and protection of my child while under the supervision of the program staff.
- 12. In case of a medical emergency, I understand that my child will be transported to the nearest hospital by ambulance if the local emergency resource (police or rescue squad) deems it necessary. I will be responsible for the cost of the transportation.
- 13. It is understood that in some medical situations, the staff will need to contact the local emergency resources before the parent and/or another adult acting on the parent's behalf.
- 14. The Edina Public Schools offers a summer school age child-care program to students in Kindergarten through grade 8, and who, additionally, are not older than age 14. Children who will be entering kindergarten do not become eligible to participate in Edina KIDS Club until the first day of their kindergarten school year. That is, they are not eligible to participate during the summer before they enter kindergarten. Eligibility ends upon the completion of the 8th grade. Children who will turn 15 during a summer session will not be eligible to participate during the summer session in which their 15th birthday occurs.
- 15. Lunderstand that I should retain a copy of this contract for my records.
