OFFICIAL MINUTES OF SCHOOL BOARD'S SEPTEMBER 19, 2022 WORK SESSION

5:00 PM Chair Allenburg called to order the work session of the School Board. Members present: Allenburg, Arom, Birdman, Gabler, Goldstein, Greene, Shaw. Staff present: Stanley, Smasal, De St. Hubert, Edwards, Leland, Monsaas-Daly, Remsing, Sailer, Woodard; Hawkinson, Strand, Van Osdel.

DISCUSSION

<u>Update on Connect and Assess Days (K-9 Screening)</u>: Board members and staff discussed Connect and Assess days. More than 2000 K-5 students were assessed over two days in August; the assessments provide data that helps inform and target instruction.

<u>2022-2023 Board Overview</u>: Board members discussed proposed meeting calendar planning document. The calendar includes annual and expected agenda items and provides an overview of the year.

<u>Concord and Countryside Building Addition Construction Bids</u>: Board members and staff discussed bids in excess of pre-bid construction estimates. Options and recommendations to re-bid the Countryside project and postpone the Concord project were discussed.

<u>EPS Calendar Board Update</u>: Board members and staff discussed calendar concepts including placement of non-student days, balancing number of days per semester, and breaks.

<u>Kids Club Wage Discussion</u>: Board members and staff discussed proposed wage increases for Kids Club staff. Additional employees are needed to maintain and increase school age care for families.

<u>Daily Substitute Rate for Retired Teachers of Edina Public Schools</u>: Board members and staff discussed the difference in daily pay rates for retired Edina teachers and Teachers On Call (TOC) substitutes.

LEADERSHIP AND COMMITTEE UPDATES

Chair Allenburg announced that there are technical difficulties with the audio/video equipment in the boardroom and alternate arrangements are being made to record the meeting. She also announced that the Special Education Advisory Committee needs two board representatives and she and Member Greene will alternate attending the meetings.
